## Coed Sand Volleyball League

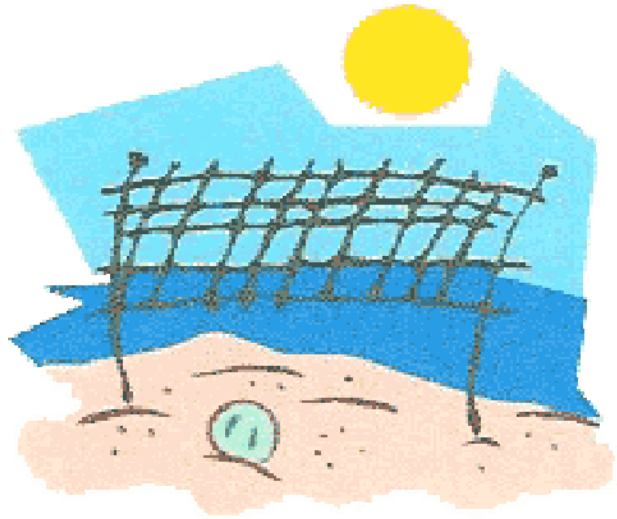
Team Registration Fee of \$150
